



Contractor Safety Plan

While performing on-site construction and/or maintenance work for Central Hudson, contractors are obligated to provide a safe workplace free from recognized hazards, for their employees, employees of Central Hudson, or other contractors, and the general public. Contractors and their employees are required to be knowledgeable of and to comply with all applicable federal, state and local laws, ordinances and regulations, including those of any agency having jurisdiction over the work site. Moreover, contractor employees are expected to report to work drug and alcohol free and remain so throughout the work day.

To perform the work on this construction/maintenance project, Contractor must submit their **Safety Plan** to Central Hudson before a contract can be activated and before work can begin.

Contractor Safety Plan Requirements

The elements of the Contractor Safety Plan may include, but not be limited to, the following.

- ❖ Compliance with applicable federal, state and local laws, ordinances and regulations, including those of any agency having jurisdiction over the work site.
- ❖ Identification of and use of personal protective equipment (PPE).
- ❖ Maintenance of a drug and alcohol free work site, including submittal to random drug testing, if applicable.
- ❖ Methods by which Contractor plans to comply with applicable safe programs.
- ❖ Listing of all chemical products to be brought on site with accompanying material safety data sheets.
- ❖ Methods for handling and disposing of industrial and/or hazardous wastes.
- ❖ Compliance with site specific safety provisions, such as smoking restrictions, housekeeping, fire safety, emergency communications, site security, tagging requirements, hot work permits, etc.
- ❖ Methods for self-assessment monitoring and enforcement of the provisions of the Contractor Safety Plan.
- ❖ Disciplinary measures for suspension and/or termination for serious and/or repeated violations of provisions of the Contractor Safety Plan.

In signing a contract for the work to be performed, the contractor agrees to monitor and enforce its provided written Safety Plan. In addition, the Contractor agrees to provide to Central Hudson, upon request, documentation of safety and regulatory training provided to its employees.
